The following **Terms and Conditions** are a part of Tulia Lopes' enrollment agreement with you - "the customer". They apply to the seminars/workshops/webinars/calls ("Seminar(s)") you have specified, and for which you wish to enroll. In these terms and conditions, all references to "I", "her", "she" or "we", "us", "our" mean "Tulia Lopes".

1. 100% Money Back Guarantee

To qualify for the money back guarantee, you must attend the whole Seminar you paid your tuition for, do every exercise, participate actively during the event, partake in every break/lunch time exercise, and stay until the event is closed. If you do those things and do not see massive value, then you will receive a refund less the cost of any third party products. 2. Payments - Paid-in-Full Option

3. Payment Deposits – Payment Plan Option: Minimum Deposit

We will not accept your enrollment until we receive your payment equal to or greater than the minimum deposit. If your enrollment deposit is not equal to the minimum deposit required, this amount will be held in credit and may not be refunded outside of the cooling off period of five working days from signature.

4. Payments – Payment Plan Option: Financial Disclosures

You must advise us of your financial details on the date of your enrollment for a payment plan to be set up. Should these details not be provided, we reserve the right to cancel your enrollment within seven German working days; then, a refund will not be available. **Please note**: Your final payment must be received by us at least 30 days prior to attending a Seminar.

5. Changing A Payment Plan

Any changes to your payment plan must be received in writing to Tulia Lopes within ten days prior to your next scheduled debit date. Refunds will not be given due to your failure to notify us within this time frame.

6. Completion Term

All seminar enrollments included in this form must be completed within a year from the original date of the enrollment as shown in this agreement. There will be no credits for enrollments not completed within this time.

For special non-recurring events, the ticket seat is void once the event is completed and no refunds are issued for missing a special "one-time-only" event.

7. Seminar Changes

If for any reason we deem it necessary to change the seminar dates, venue, speaker, content, title or hours, we may do so by notifying you in writing of the changes we make. In this case you retain the right to reschedule your enrollment without penalty.

8. Choosing to Cancel or Reschedule Your Enrollment

Should you decide to cancel or reschedule your enrollment shortly before the date of a seminar, Tulia Lopes will not be able to avoid the costs involved for your attendance at the

event. Therefore, we will charge a fee for changing your enrollment as indicated below. All requests to cancel or reschedule your enrollment must be received by Tulia Lopes in writing, by email or fax prior to the day of the seminar you enrolled in.

9. Cancelling Your Enrollment Within a 3 Day "Cooling-off Period"

If you choose to cancel your enrollment for any reason within 3 business days of completing this form (the "cooling-off period"), then we will refund you the total amount you have paid to us less a 10% administration fee and the value of any physical or digital products received. Please note all product like handout manuals is non-refundable. For your refund to be processed, please allow up to ten business days after your refund has been approved.

In short: Date of Cancellation: Within three business days of enrollment -> Deduction of refund = 10% of full enrollment cost.

10. Cancelling Your Enrollment After The 3 Day Cooling-off Period

If you choose to cancel your enrollment for any reason <u>after</u> the three business day cooling-off period, you will receive a credit only. Credits may not be claimed as refunds; but may be applied towards an enrollment in any other seminar or product offered by Tulia Lopes within six months. 14. Username (if applicable)

Please check you junk mail folder, if you don't think you have received anything. Home studies, that are bonuses, are not delivered until after you completed the seminar (that they are bonused from).
